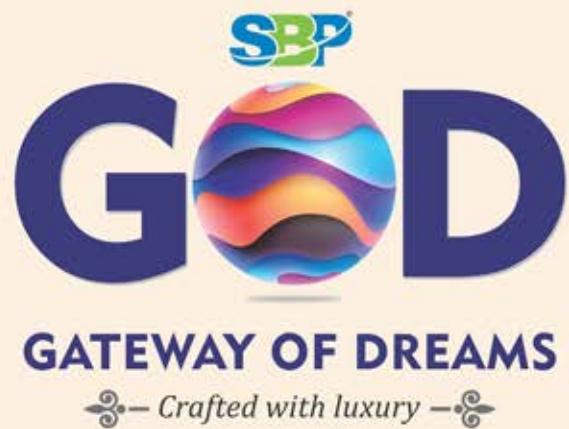

- 3) The Developer will communicate its decision to the Applicant/S within 30 (Thirty days) from the date of receipt of the sanctioned plan from the concerned authorities. i.e. from the office of Chief town Planner, Punjab. If the Application is not accepted, the Application money shall be returned and if accepted the Allotment letter will be issued and later on Apartment buyer Agreement would be execute Spelling in details of the terms & Conditions of the Allotment. No withdrawal of the Application money would be allowed.
- 4) That in case Letter of Expression of interest has been issued , the same shall not vest any right with the Applicant herein to get Allotment of a flat in a Project and the said right shall be vested only in the issuance of Allotment letter only.

I/WE would like to have refund of the amount deposited with simple interest at the rate of 8 percent per annum calculated for the period for which such amounts have been lying with the developer (Interest to be calculated from the date of encashment of the respective cheques as per the payment plans) (Interest Commencement Period) from the date of encashment of amount in Developers bank account. The interest shall be Payable by the Developer only if I/WE make timely payment as per the payment plan attached hereto or not otherwise any such case only the principal amount would be refunded.
